PHILANTHROPIC LEADERS HONORED AT DONOR EVENT

Each year we take time to recognize our donors and celebrate philanthropy in our community. At this event we also honor those who have provided philanthropic leadership for the benefit of the community and beyond. This year we recognized the Spesia Family and Kathy and Tom Cawley.

Lori and Doug Spesia instilled the spirit of philanthropy in their children—John, Chris, David and Sarah—through their strong Catholic faith and daily example. Doug Spesia was a founding Trustee of The Community Foundation of Will County. He and Lori set up one of the Foundation's first Donor Advised Funds. Their sons, John and Chris, along with their wives followed in their footsteps by establishing their own Funds. When Doug passed away three years ago, their son Chris took Doug's place on the Board and has grown into his own valuable role. But the Spesia

family has done more than just help the Foundation. Their philanthropic spirit, financial resources, time and talent have been shared widely and have touched organizations that they value like Daybreak Center and Catholic Charities, Joliet Montessori School, The George Werden Buck Boys & Girls Club, local parishes, a Benedictine Monastery, and local Catholic education institutions.

Lori Spesia spoke on behalf of the family and shared how she was able to use their Fund to achieve what her son Chris said, "Was a dream she didn't know she had yet." Lori and Doug were moved when they visited Malawi Africa on a mission trip and eventually met what Lori likes to refer to as "her fifth Spesia child," Father Philip Mbeta, a Catholic priest from Malawi. As their friendship grew with Father Philip, they became interested in helping him

with his work. When Doug passed, memorial gifts were made to their Fund at the Foundation. Lori felt that Doug would want to use these gifts to support Father Philip's work. Because a Community Foundation cannot make donations outside of the United States, Lori was able to make grants to a local parish that, in turn, directed the funds to help build a Montessori school in a village in Malawi in Doug's honor. The adult Spesia children initiated their own projects to help the local people as well. John spearheaded a fresh water initiative and, with the help of local Rotary Clubs, built drinking wells close to the village. The Spesia children and grandchildren have been taking turns going to Malawi with Lori as they continue to support Father Philip and his work.

Tom and Kathy Cawley both began their careers in education. With a shift to the financial advising field, they established The Voyager Group in 1999, which resides in a restored 1840's farmhouse near Essington and Division in Joliet. Kathy and Tom had been looking for a way to give back locally and they felt that the Foundation was a place where they could impact community needs. Kathy came onto the Foundation's Board and sits on the Grants Committee. When Tom and Kathy started a Fund at the Foundation, they did it in the name of their business. And it wasn't just a good financial decision for them to organize their charitable giving, but it reflected the spirit of their values, and again true to their spirit, it became an opportunity to educate. They set up an advisory council of clients with similar values, to explore together issues of concern in the community, discuss solutions and use The Voyager Group Fund to address them. This advisory council has come together around the issue of wanting to improve the quality of life for young people in the community. "We are just getting started, but even small contributions to the Fund over a long period of time will add up," said Kathy.

IRA Charitable Rollover

**DON'T MISS THIS OPPORTUNITY!
Congress extended legislation through December 31, 2013 that allows donors age 70-1/2 and older to gift up to \$100,000 from their IRAs to charity.**

- Your gift can be any amount up to \$100,000.
- Your gift can count toward your minimum distribution.
- You must be age 70-1/2 or older.
- You must make a direct rollover, not a personal distribution.

It's easy to make a gift by directing your custodian to transfer a portion of your required minimum distribution directly to charity. The gift is not counted as part of your taxable income, so it is tax-free! FOUNDATION AWARDED \$54,500 IN GRANTS TO EIGHT AREA NONPROFITS

Grant making is one of the roles of The Community Foundation. Each year we invite nonprofits serving Will County to participate in our competitive grant cycle. This year we had 31 organizations requesting more than \$370,000 in funding. With \$54,500 available, our grants committee, which is made of board volunteers, reviewed applications and made decisions based on community needs working in the Foundation's priority areas of health, human services and education. "This year we were pleased to include a grant for the arts made from the Wadsworth Family Cultural Arts Endowment at The Community Foundation of Will County," noted Grant Committee Chairman, Larry Lorimor.

"As the Foundation continues to connect donors to community needs, the nonprofit community is benefiting. During this year's competitive grant program a \$6,000 grant was matched by an anonymous grant from one of our Donor Advised Funds. Also, a Foundation board member directed additional funding towards another project, together directing \$8,500 in additional funding to our grantees this year," said Executive Director, Michael Trench.

The following is a list of the 2013 grant recipients:

Aunt Martha's Youth Service Center, Inc. - \$2,100 to establish a Reading for Life Corner to encourage literacy enhancement. This project was done in collaboration with the Joliet Chapter of the National Hook-Up of Black Women and will be located at Aunt Martha's new Joliet Community Health Center on the old Silver Cross Hospital property.

CASA of Will County - \$5,000 to purchase computers and related technology to better serve their

volunteer base, which is critical to CASA's work and requires high levels of training and reporting.

Center for Correctional Concerns - \$6,000 to purchase computers to allow inmates to continue to take the GED test in 2014 and beyond, when the paper version of the test is eliminated. Passing the GED helps inmates reintegrate into society with a more productive life and avoid reoffending.

Guardian Angel Community Services - \$4,000 to create digital stories told by clients as a means to raise awareness, start conversations, and share resources for help for victims of domestic violence. The videos will include special outreach to the growing Latino population in Will County.

Jennifer S. Fallick Cancer Support Center - \$4,500 to pilot the Expressive Arts Program in Will County. This program provides a medium for expression to help people of all ages, process their cancer experience. This grant was funded by the Wadsworth Family Cultural Arts Endowment at The Community Foundation of Will County.

Northern Illinois Food Bank - \$14,600 to purchase various refrigeration and storage equipment for the following network partners: Good Shepherd Food Pantry (Romeoville), St. John Lutheran Food Pantry (Joliet), Morning Star Mission Soup Kitchen (Joliet), Sacred Heart Soup Kitchen (Joliet), Life Line Food Pantry (Joliet), Family Outreach Program, Inc. (Crest Hill). In addition, provide two Mobile Pantry distributions at Kuzma Care Cottage in Wilmington and Second Place Pantry in Monee.

Power Connection - \$11,000 to purchase a refrigerated box truck with a lift gate to pick up and deliver food donations from local merchants to the warehouse. Power Connection is

located in Bolingbrook and serves the "working poor" with education, training and assistance that includes a very busy food pantry.

United Cerebral Palsy of Illinois Prairieland - \$7,300 to purchase a Youth Symmetry and a 51" Supine Stander. These standers will be used during classes to physically help students improve bone growth and digestive health. In addition, they prevent soft tissue contractures and bone deformities. Socially, they improve student communication and interaction with fellow classmates and teaching personnel.
